1. Purpose

Welcome to the Stoney Point Fire Department! You are about to embark on what we hope is a challenging and gratifying career in the emergency services.

This manual is to be used as a reference guide and training aide by new members of the Stoney Point Fire Department. It describes in detail the procedures and requirements that members must learn and abide by to be successful contributors to the organization. The information is based on National Fire Protection Association (NFPA) standards as well as the Stoney Point Fire Department's Bylaws, Standard Operating Guidelines (SOG's) and Rules and Regulations.

Please review the entire manual thoroughly. If there are any questions please direct them to one of the Fire Department Chief, or line Officers. You will be evaluated on your understanding and proficiency of this information in written and/or practical form.

Author's Note: This manual is a work-in-progress. It will update as new information becomes available. As you progress through your probationary period and, hopefully, use this manual as a guide, if you think of any suggestions as to things you would like to see added and/or changed, or if any information seems confusing or unclear, please let us know so that we can make the appropriate improvements. Thank you for your feedback!

2. Introduction to the Stoney Point Fire Department

2.1 Organization

The Stoney Point Fire Department was chartered on June 14, 1964. Currently we protect an approximately 21.5 square mile area here in Cumberland County and approximately 4.5 square miles in the City of Fayetteville. Our population is approximately 7,700 and the area we protect is valued at close to 800,000,000.00 and we have an Insurance rating of 5/9 which was issued in May of 1997. Our department is currently in the process of acquiring National Accreditation through the Center of Public Safety Excellence (CPSE) and we will be the 1st VOLUNTEER department in the State of North Carolina to achieve this quest and only the 2nd VOLUNTEER department in the entire nation.

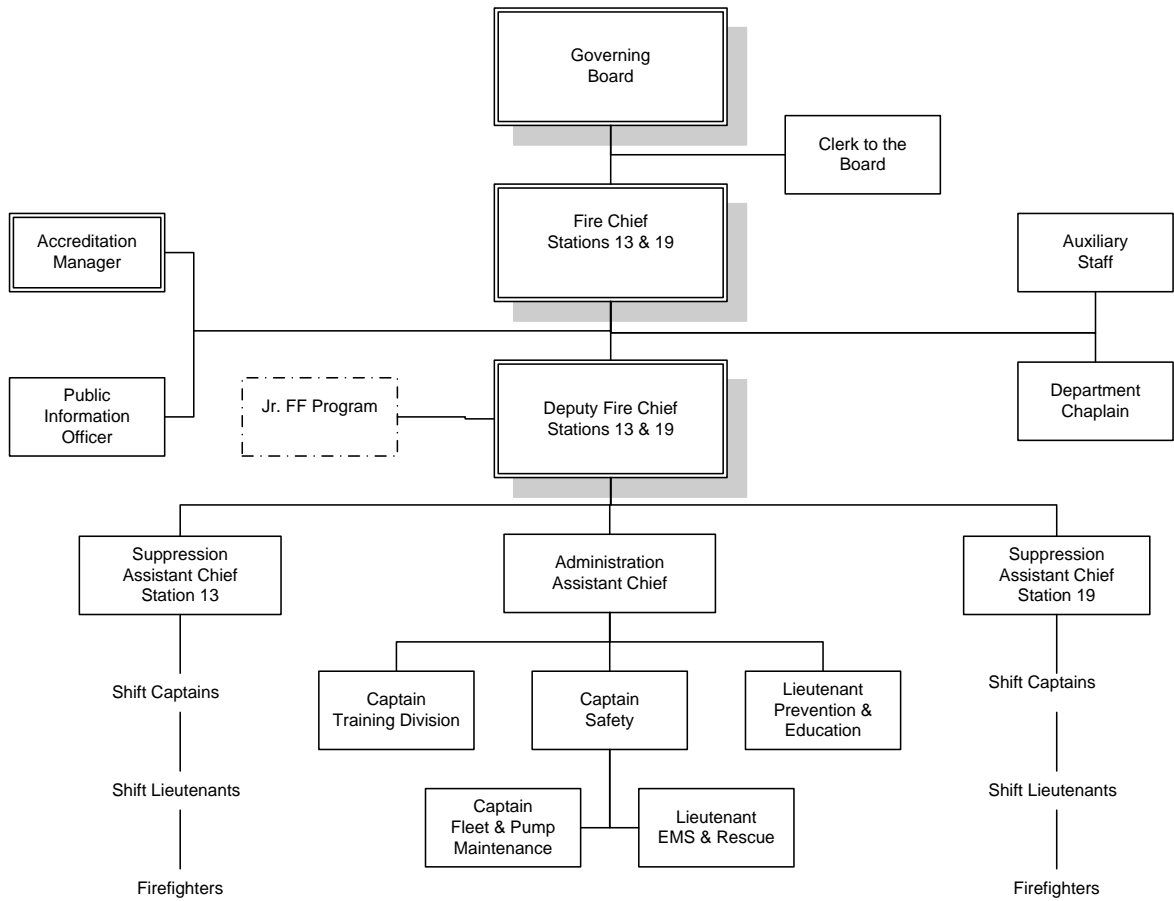
2.2 Fire Department Officers

The Fire Department Officers are responsible for a wide variety of tasks both on and off the fire scene. They are categorized into Chief Officers (Fire Chief, Deputy & Assistant Chiefs) and Line Officers (Captains, Lieutenants).

The Board of Directors appoints all Chief Officers based on qualifications. The Fire Chief then appoints the officers from a list of tested and qualified candidates. The test is given as needed and a list is generated from the individuals who pass the exam per our department By-Laws. Our By-Laws can be found on our department web site at www.stonepointfire.com under the **Governing Body** section. Once appointed to an officer position the selected candidate will stay in that position so long as they are meeting the requirements set forth in the SPFD SOG's and rules and regulations.

As a new member of the Department, and after you complete Phase I of our training program you will be assigned to a duty shift under one of the volunteer Asst. Chiefs/Captains & Lieutenants. Duty Shifts are from 7 PM until 7AM Sunday, Monday, Tuesday, Wednesday and Thursday Nights. (There is also a Friday & Saturday Night Shift a duty that is rotated by all members and posted separately) The Officers on your assigned duty shift and the training staff are responsible for establishing and maintaining contact with you throughout your probationary period and beyond. They will ensure that you are issued the proper equipment and they will direct your training so that you fulfill the requirements for membership. Any concerns or issues that you have should be directed to your assigned Captain/Lieutenant. If the Lieutenant/Captain are unable to resolve your issue, they may escalate it to a Chief Officer if necessary.

3. Medical Requirements

Each member is required to obtain or show proof of a negative tuberculosis test and the Hepatitis B vaccination series before they are eligible to participate or ride the fire apparatus. These tests and vaccinations can be obtained at the US Health Works Occupational Health Clinic located at the Bordeaux Shopping Center. Services are coordinated through the Fire Departments Medical Services Staff and are paid for by the Fire Department. Services are scheduled within 10 days of completing the Pre-Basic or Transfer Training Packet.

Members are also provided and encouraged to get a general physical to insure they are fit to perform the duties of a firefighter.

Medical records are maintained on every member and they are kept in a confidential file at the Fire Department. Please provide these records to the appointed EMS Staff or the station administrative assistant.

4. Training Requirements

4.1 Initial Training Requirements

The following basic training must be completed before the probationary member is eligible to ride on any fire apparatus. It is expected that this be done within about three months. Once the training is completed, the Chief Officers will evaluate the member's performance and grant permission to ride fire apparatus accordingly. The member may be exempt from these requirements if they can show proof of equivalent certification and/or experience, at the discretion of the Fire Chief.

- **Stoney Point Fire Department in accordance with the Cumberland County Contract participates with the National Incident Management System (NIMS) training requirements and every new member must complete the **ON-LINE NIMS** classes identified in your Pre-Basic/Transfer training packet prior to the start of the Pre-Basic or Transfer Training Program.**
- **Stoney Point Fire Department Blood-borne Pathogens:** In-house training session offered on an as-needed basis.
- **Stoney Point Fire Department Basic Hazardous Materials Awareness / Operations:** Each member shall be required to meet this requirement to respond to any vehicle, or Hazardous Materials related incident. **This **SHALL** be completed within 12 months of joining the SPFD.**
- **Stoney Point Fire Department Interior Qualifications:** *It shall be the policy of the Stoney Point Fire Department that before **any** member is allowed to actively participate in actual fire scene operations that involve interior fire attack, that the member meet the requirements of **NFPA 1403 Live Burn Standard** as outlined in the Pre-Basic Training Packet provided to each new member.*

4.2 Ongoing Training

The fire service is constantly changing and evolving, thus to remain effective firefighters must continue to attend training far beyond the initial requirements. The following sections describe additional requirements and recommendations that are intended to guide the new member in choosing the appropriate training classes to attend. **IT IS POINTED OUT THAT THE SPFD WILL NOT SPONSER ANY NEW MEMBER TO ATTEND ANY CERTIFICATION CLASSES (FIRE/EMS or RESCUE) UNTIL THE PRE-BASIC TRAINING PACKET IS COMPLETE.** The only exception is a class that is being hosted at SPFD that is in line with the on-going training objectives.

4.2.1 Training Organizations

Fayetteville Technical Community College sponsors most of the training in Cumberland County. However Fire, Rescue and EMS certifications courses once eligible to attend maybe taken at regional community college. (Robeson, Sand-Hills, Bladen, Sampson Counties etc) Local and regional training/class schedules can be accessed on the training board at Station 13 & 19. All members are encouraged to check this schedule regularly and take the initiative to sign up for and attend classes that are of interest to them.

Members are not limited to taking classes within Fayetteville Technical Community College if they are willing to travel, they are encouraged to attend classes anywhere, including at out-of-town weekend seminars, neighboring counties, etc. Currently, the member must assume all financial responsibility for travel and lodging the SPFD however will provide seminar funding for certification course fee as long as this course is part of our primary provider function certification process.

4.2.2 Additional Certification Requirements

The probationary member is expected to obtain their **North Carolina Hazardous Materials Operations certification within one year after joining the department – (NO EXCEPTIONS)**. This 40-hour certification class is typically given over two weekends, and teaches firefighters important aspects about responding to, identifying and mitigating hazardous materials incidents. Hazardous materials may be present at just about every type of emergency incident, from a simple vehicle crash to a full-blown structure fire. Thus it is vital that every member be properly trained to handle these situations in a safe and effective manner.

The probationary member is encouraged to begin working towards their **North Carolina Firefighter I / II** certification as soon as possible after completing his/her pre-basic requirements. This certification consists of over twenty separate classes, typically given at night at various fire departments throughout Cumberland County that cover basic skills and concepts of firefighting. Aggressive members may complete this certification in about 8 - 10 months taking night /day or weekend classes. More typically, it will take 1 - 2 years. **If the member has not received their Firefighter I / II certification within 3 years of joining the department, their membership in the department is subject to termination. (Military members subject to frequent deployments in our nations on-going war on terrorism will have their time extended IF they are frequently deployed)**

4.2.3 Additional Certification Recommendations

The Department is recognized as a Basic/ Advanced Life Support provider in Cumberland County. If a member is interested in providing patient care, they must complete the Emergency Medical Technicians (EMT) or Basic Medical Responder certification. This certification is required for members wishing to participate in patient care. Every department member MUST obtain and maintain an active CPR certification.

4.2.4 In-House Training

The Fire Department offers scheduled in-house training every Thursday from 19:30 to 22:00. Members are also scheduled for training during their assigned duty night in order to complete required benchmark/rope training skills. All members are expected to attend as many of these sessions as their schedules allow. Every member must complete a minimum of 240 hours of fire service (ISO) training per calendar year. Members are always encouraged to obtain training from other fire departments and organizations. However, we feel that it is important to train with others within the Stoney Point Fire Department since we will be running calls together. Training credit from other departments that is properly recorded and verified will be posted on those members participating in the training Firehouse training record.

5. New Member Procedures

The following sections contain a brief summary of procedures that are of particular interest to new members of the Stoney Point Fire Department. Each of these procedures is explained in more detail in the Standard Operating Guidelines (SOGs). All new members are expected to read and understand the SOGs and By-Laws and abide by them. If there are any questions about the SOGs or By-Laws, contact your Officer or a Chief Officer.

5.1 New Member Packet

New members must complete all administrative requirements such as the department Application, Fire House Personal Information Form, Medical History Form, and Benefit Form. All new members must also turn in prior to the start of any training a complete criminal history & background verification form. This can be obtained through your local Sheriff's Office or Clerk of Court. New members will receive a Pre-Basic/Transfer Training Packet from the Fire Chief when they first join the Department and prior to the official Phase I training date. This packet contains important information concerning training and other requirements pertaining to the SPFD. The Fire Chief or another Chief Officer in his absence will review all items in the packet with the new member and ensure that all the necessary forms are completed and turned in to the administrative assistant.

5.2 Probationary Period

All new members of the Fire Department undergo a 12-month probationary period during which they are expected to begin their firefighter training and become familiar with the operations of the Fire Department. Those members entering the Department with prior firefighting experience may undergo a shortened probationary period at the discretion of the Fire Chief. They will however complete the Transfer Training Packet prior to being allowed to participate in any fire department functions and or calls.

During the Pre-Basic Training Phase, an Officer, Engineer or Sr. Firefighter must supervise the new member or a qualified designee on the fire scene at all times. The extent of the new member's participation at fire scenes will be at the discretion of the Officer in Charge of the incident scene. .

At the end of the 12 month probationary period, and there has been no problems with the member his/her membership becomes permanent. All Firefighters serve at the will of the Fire Chief. Probationary periods may be extended for military members subject to frequent deployments.

5.3 Monthly Business Meetings

The Board of Directors holds a business meeting on the 3rd Tuesday of each month at 7:30 PM. If this falls on a holiday, the meeting may be rescheduled at the discretion of the Board President. The meetings are rotated between stations 13 and 19 with no meetings scheduled during the months of July and August due to vacations. Meetings are announced and posted in both departments Names Board located in the Foyers of both departments.

Fire Department members will have a short administrative meeting prior to training each Thursday at 7:30 PM at Station 13, unless otherwise announced. The last Thursday of each month is SNACK night whereas the auxiliary provides food and refreshments immediately after the administrative portion of the meeting and prior to scheduled department training.

5.4 Fire Department Equipment

5.4.1 Pagers

Probationary members will be issued a fire pager and a charger at the completion of their Pre-Basic Training/Transfer Packet. Only members that reside within a reasonable distance from either department will be issued a fire pager. All emergency incidents are dispatched on the fire pager and lamresponding.com which send the dispatch and all other information via a text to each members cell phone.

5.4.2 Turnout Gear

Probationary members will be issued their own personal set of turnout gear if available at the conclusion of Phase I of the pre-basic training packet. If turnout gear of the appropriate size is not available SPFD will accommodate the new member as much as possible until more can be purchased or acquired. All members are expected to properly maintain their turnout gear and other assigned SPFD equipment, and report any problems to their assigned Officer.

5.5 Responding to Fire Calls

5.5.1 Personal Vehicles and Red Lights

All Stoney Point Fire Department Members **MUST** respond to the Fire Department to which assigned. The **USE of ANY RED LIGHTS OR OTHER WARNING DEVICES IS PROHIBITED**. Members are not authorized to drive their POV to any incident scene. (However a member in his/her normal way of travel to the Fire Department during an incident call that directly passes by an emergency scene **MAY** stop and render assistance if the FD has not arrived on the scene. Because the member will not have his/her protective gear he or she must yield to the arriving fire department or EMS personnel. He or she must either leave and go to the station or coordinate with the Officer in Charge for another support role where protective gear is not required.

I want to re-emphasize that no member of the SPFD **SHALL** utilize red lights or other warning devices in their personal vehicles. While responding members must obey all traffic laws and obey speed limits. Any member determined to be acting outside this policy will be dealt with and could face suspension or termination.

5.5.2 Riding Fire Apparatus

Probationary members are eligible to ride fire apparatus after they have completed the PHASE 1 training requirements as outlined in the Pre-Basic Training Packet, or have been approved by the Fire Chief. Exceptions may be made at the Fire Chief's or Chief Officers discretion. Probationary members **SHALL NOT** drive fire apparatus, nor should they ride in the officer's position unless approved and/or supervised by an officer or senior firefighter.

Members **MUST** don ALL personal protective equipment before the apparatus is set in motion. Members must be in proper passenger seats and have seat belts and safety bars (where available) secured at all times while the apparatus is in motion. **UNDER NO CIRCUMSTANCES WILL ANY MEMBER RIDE ON THE OUTSIDE OF THE FIRE APPARATUS!** – For more response information read and comply with SPFD SOG -

All firefighters who respond to incidents will receive call reimbursement. The rate is currently \$3.00 per call for responses and \$ 1.50 for stand-by. Those members that Stand-By and assist with clean up and getting our apparatuses back in service will receive full credit. (Probationary Firefighters are not included)

All qualified members that participate in the overnight duty program receive \$ 5.00 for every night spend at the Fire Station. Checks are given out at the annual department family Christmas Dinner held on a designated Sunday in December each year.

The Stoney Point Fire Department utilizes clear-text (Plain English) radio transmissions instead of 10-codes in order to ensure that communications are clear and understandable.

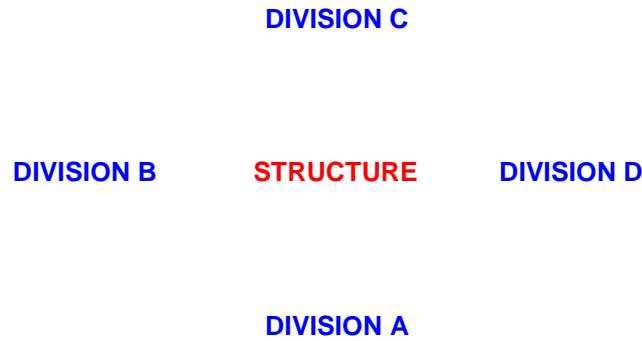
5.5.4 Conduct At The Fire Scene

Members of the fire apparatus crew must remain on the apparatus until the apparatus officer gives out their assignments. Probationary members **MUST** remain with the apparatus officer or other designated member and follow their instructions. If a member does not understand their assignment they should ask for clarification from the officer. If a member is not comfortable with an assignment they have been given, they should not hesitate to inform the officer. Probationary members should treat every call as a learning experience, and be observant and ask questions at the appropriate times.

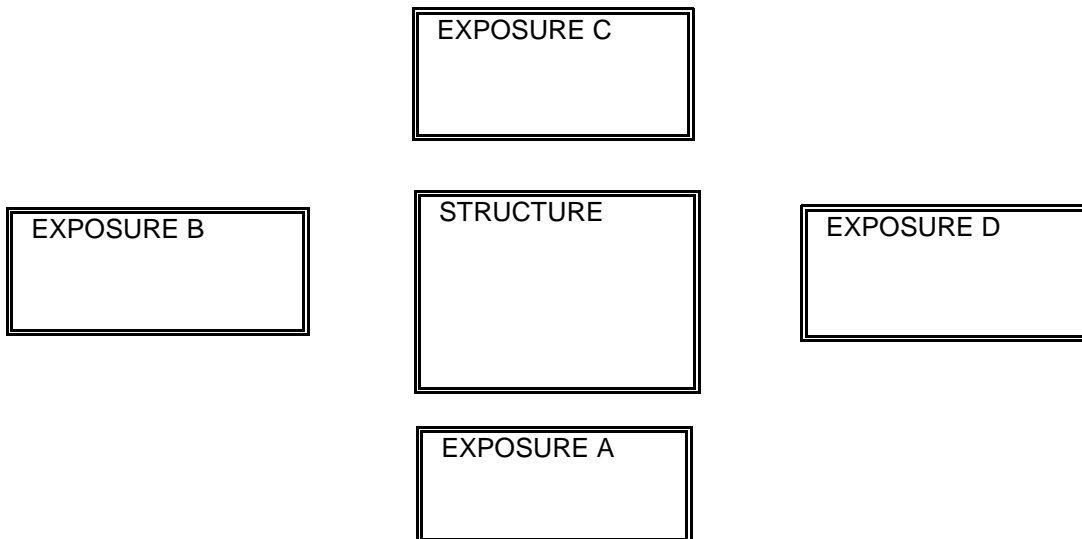
The Stoney Point utilizes the Incident Command System (ICS) on all incidents. Each member must be familiar with this system and understand the terminology that is associated with it. Refer to the diagrams on the following page for a better understanding. You will also receive training on the ICS program during your Pre-Basic/Transfer Training program.

- A. Division A will always be on the side of the structure facing the street (address side).
- B. Division B will be on the side of the structure to the left in a clockwise manner.
- C. Division C will be at the rear of the structure on the opposite side of Division A.
- D. Division D will be on the side of the structure to the right.

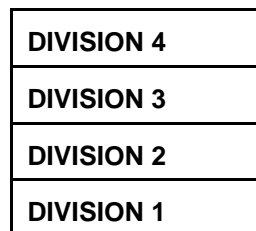
An example of the Division A, B, C, D designation system:

5.6 Returning From the Fire Scene

All members/probationary members must return to the fire station on the apparatus on which they rode to the fire scene UNLESS another arrangement is agreed upon between the apparatus officer and the probationary member. All members are expected to remain at the fire station and help perform any tasks necessary to put the apparatus back in service.
